Dear Chief Secretary to the Treasury,

We write as an organised grouping of Labour MPs representing former coalfield constituencies across England, Scotland, and Wales, to ask you to address the ongoing unfairness relating to the British Coal Staff Superannuation Scheme (BCSSS).

We are extremely grateful that the Labour government delivered long overdue justice for former miners and their widows, in the first Labour budget, by authorising the transfer of the £1.5 billion Mineworkers Pension Scheme Investment Reserve Fund. This historic decision significantly benefitted our constituents, with many receiving a 32% increase in their pensions. The positive impact is felt deeply across our communities and local economies.

However, the matter of securing pension justice for the mining communities remains incomplete. When addressing the legacy of the coal industry, it is essential to include everyone who contributed to its success, those who worked underground, served in canteens and offices, or took on roles as deputies and managers. Parity must be achieved between the MPS and BCSSS to ensure fair treatment for all former British coal workers.

To this end, we call on the government to forgo the final £2.3 billion payment from the BCSSS reserve, due in 2033. Transferring this reserve would deliver fairer pensions to BCSSS members, who include many individuals moved from the MPS to the BCSSS with minimal change to their roles. Nearly three-quarters of BCSSS members carried out work underground comparable to that of MPS members, with pensions that fall within a similar range.

Furthermore, we must address the specific injustices faced by women in the coal industry. These women, the majority of whom are BCSSS members, were often paid significantly less than their male colleagues and remain excluded from pension justice in retirement. Correcting this historic inequality is a matter of principle and fairness.

Time is of the essence. With approximately 2,000 BCSSS beneficiaries passing away each year and that number increasing rapidly due to the age of the beneficiaries. Urgent action is required to ensure justice is delivered to those who powered this nation. We are confident this issue can be resolved swiftly if the government commits to achieving parity between the two schemes.

We understand that the BCSSS trustees have already contacted you regarding this matter and that the Minister for Industry has written to you about the scheme. We urge you to prioritise this issue and address it without delay, ensuring no miner, widow, or coalfield family feels excluded from the justice they deserve.
